Use of psychological tools and intervention methods in correctional work: A brief overview

It is commonly accepted that scientific classification, assessment and evaluation are essential to measure the risks and vulnerabilities of prisoners and also to formulate effective

treatment programmes for their reformation and rehabilitation. Use of psychological tools and instruments for screening, assessing and classifying prison inmates is very common in advanced prison systems across the world. Prison systems from across the globe have developed, experimented, and implemented several comprehensive risk assessment methods in order to develop intervention strategies targeting the criminogenic needs and risks of prisoners. Further it is helpful in reducing recidivism and to enhance public security. This writeup is an attempt to highlight some examples of psychological tools and assessment methods adopted by prison services of few countries.

In Australia, the Western Australian (WA) Correctional Services use an 'Offender Management Assessment Framework' which

includes initial screening, general risk and need assessment, and crime-specific assessment. Their correctional services employ the Risk of Reoffending – Prison Version (RoR-PV) as a screening tool to determine the next level of assessment and targeting of criminogenic programs. Offenders showing a higher risk of reoffending will be assessed with the help of the 'Level of Service/Risk Need, Responsivity (LS/RNR)' tool. This LS/RNR is a comprehensive and gender-informed measure of risk and needs factors to inform the offenders' risk of reoffending, rehabilitation needs and most relevant factors related to planning of educational, vocational and other treatment programs inside the prison. The WA Correctional Services also use offence specific assessments for general violence, family and domestic violence (FDV) and sexual offenders.

In Hong Kong, the Correctional Services Department (CSD) has developed a management tool known as the 'Risks and Needs Assessment and Management Protocol for Offenders' in 2006. This Protocol assesses the re-offending risks and rehabilitative needs of individual offender so that appropriate rehabilitative programmes could be developed to reduce their chances of

re-offending and help them reintegrate into the society. It is an evidence-based and scientific rehabilitation instrument for classifying offenders into levels of risk and to identify and to prepare treatment programmes to address prisoners' needs such as anti-social attitudes, weak employability etc. which are generally related to recidivism. It helps prison authorities to predict the static re-offending risk of offenders by considering quantifiable historical factors, including age at admission, conviction history, behaviour during incarceration, act of escape, any breach of supervision, nature of sentence, level of education, employment status, drug abuse and addiction history, gang association, etc. Subsequently, Prediction Tables are prepared wherein prisoners are classified into one of the three re-offending risk categories, i.e. 'Low', 'Moderate', and 'High'. Apart from that a Needs Assessment will also be conducted to identify a set of personal and interpersonal factors and behaviours associated with offending, which are dynamic risk factors. Seven need domains, including 'Employment', 'Family/Marital Status, 'Associates', 'Drug Abuse', 'Community Functioning', 'Personal/Emotional' and 'Criminal Attitude', are assessed by rehabilitation officers through interviews. Each need domain is rated in terms of severity as 'Considerable Need', 'Some Need', 'No Need' and 'Asset'. Supplementing data will be collected from family, case files and past records of the offenders. This assessment helps to determine the rehabilitative planning and programme matching that are suitable for the targeted offenders. The structured treatment programmes with self-help assignments are conducted in groups by staff of Rehabilitation Units and Psychological Services Sections. Since 2006, more than 38,800 persons in custody have undergone re-offending risks and rehabilitative assessments.

Further, the rehabilitation officers evaluate precisely the rehabilitative need domains of the offenders and arrange appropriate programme matching and counselling services throughout their incarcerations. The CSD also invites nongovernment organizations (NGOs) to participate in the counseling groups for effective deployment of resources of NGOs. Coupled with the professional clinical psychologists and dedicated rehabilitation officers in the implementation of the rehabilitation programme, together with strong community support, the reintegration of offenders have become more promising and efficient. Over the last decade, the recidivism rate in Hong Kong has decreased from 39.9% based on 2000 as the year of discharge to 27.1% based on 2015 as the year of discharge.

The Malaysian Prisons Department also implements various assessment tools. The most prominent tools are KYKO (Know

yourself-Know others) which is an inmate profiling tool, and psychological test which consists of DASS (Depression, Anxiety and Stress Scale), BDI (Beck Depression Inventory), DAST-20 (Drug Abuse Screening Test – 20) and URICA (University of Rhode Island Change Assessment Scale). These tests are conducted within 14 days upon inmates' entry into prisons and repeated after 6 months. These tools measure and detect possible risk and mental state of each inmate and also assist the prison management to place the inmate at an appropriate placement and supervision.

KYKO - an acronym for 'Know Yourself, Know Others' - adapted from Sun Tzu Art of War, assists the prison officers to generate and develop winning strategies to make things happen. KYKO is an integrated five dimensions model of personality to map out the pattern of behavior of prisoners and to find solution of the problem caused by human differences. KYKO serves to assess risk at an early stage of imprisonment and the prison administration will be able to place the inmate at the right accommodation block. The results of the tests provide information on the qualities and behavioral pattern of the inmate that causes the problems. The information provided will determine issues faced by inmate for better rehabilitation program and treatment. KYKO also assess the readiness for parole and community rehabilitation programme.

One of the notable step the Malaysian Prisons have taken is a specialized screening for prisoners admitted under related offences. Such inmates are screened by using Drug Abuse Screening Test-20 (DAST-20). The purpose of DAST-20 is to provide a brief, simple, practical but valid method to identify individuals who are abusing psychoactive drugs and show a quantitative score of problem related to drug use and misuse. Inmates with high scores are usually sent for Methadone programme (A comprehensive treatment program that involves the long-term prescribing of methadone as an alternative to the opioid) and there is also Therapeutic Community (TC) programme for the inmates who show medium or less tolerance for drug misuse. URICA (University of Rhode Island Change Assessment Scale) is a self-report measure that is used to assess an individual readiness to change when entering prison. URICA test is also conducted if the inmates are qualified for the parole system or any community rehabilitation system. The reason is to evaluate the readiness of an inmate to change. The inmate's level of motivation for change and the information they reveal in the URICA will be used to guide treatment options. It provides strategies and processes that can guide a person through significant life changes. If the inmates show significant changes, then they are qualified for parole and community rehabilitation programme.

Use of psychological tests and assessment tools to determine risk and needs smoothes the prisoner management and rehabilitation. This will help the prison departments to proceed through the right path to achieve the mission of corrections and developing productive citizens through effective rehabilitation and strategic integration. Utilization of such scientifically developed tools and methods for assessment, classification and treatment of inmates are not widely used in our Indian prisons. However, there are some innovative

practices being introduced. In 2015 the Telangana State Prisons have launched a program named 'Unnathi'- a cognitive behavioural change intervention programme, with an aim to curtail recidivism by helping prisoners to accomplish five R's – reason, reset goals, reform remain, responsible, and return not to prison. Each batch consisting of 30 prison inmates undergo training in 12 aspects, right from discipline, psychological therapy to de-addiction and other core issues in a 20-day session. These types of correction oriented treatment programmes need to be incorporated in imprisonment. Otherwise, our prisons will continue as centers of mere custody, serving no correctional work at all.
