DIRECTOR'S DESK

Prison Guarding Force's Attitude toward Prisoners and its Impact on Prisoners' Reformation

The fundamental task of prison guarding force is to maintain control over prisoners, thereby assuring that the prison will operate in a smooth and orderly fashion. However, as the conditions of imprisonments have changed over the years, the duties and responsibilities of the line staff, the guarding personnel, are also expanded to change towards correctional roles. In fact this aspect has attracted the attention of policy makers sometime ago.

The All India Committee on Jail Reforms (1980-83) opined in their report as follows:

"Hardly less important is the position of the lower officers of the prison – warders and head warders. These officers also possess great opportunities for good or evil in dealing the prisoners and the important role played by this staff in the work of prison administration has not been as clearly recognized as it should be. The prison staff, down to the warder, should be recruited with care, properly trained and paid a salary sufficient to secure and retain faithful service."

No sensible prison systems can undermine the role of prison guarding personnel in correction of prisoners' behaviours. On the other hand, more emphasis has to be placed on these staff cadre. The reasons are multiple. First of all, more than 80% of prison workforce constituted of guarding personnel. Further, they are the personnel who mingle with the prison inmates for a considerable duration of time. Further, as far the prison inmates are concerned, prison warders are the first point of contact for their every problem. Similarly all rules, regulations and administrative polices in prisons are being implemented through the hands of prison warders. Hence it is very important for every prison institution to evolve their guarding force with good attitude, proper skills and necessary knowledge.

The Working Group on Prisons (1972-73) observed that "the efficiency of an organization is determined by the calibre, training and motivation of the personnel manning it. This is particularly so in respect of organizations that deals with human beings instead of machines." The selectors of personnel in this area of public administration as in the other uniformed services have to look for physical fitness and courage, leadership and man-management qualities as well as the dependability which is guaranteed by a balanced personality. In addition, they will have to look for endurance qualities, for broad interest in social welfare and a flair for human relationship.

People with a positive attitude make things happen. As already stated, the warders' role in the prison system encompasses many tasks, which ultimately impact the inmates under their supervision. One of the most important goals of prison staff is helping inmates change their patterns of behaviour which led to their offence and subsequent imprisonment. The way prison warders treat the inmates under their supervision is largely influenced by the attitudes and perceptions they hold towards prisoners.

Some empirical studies have examined prisons staff characteristics and attitudes towards inmate treatment and rehabilitative programs. Outcomes of these studies proved that greater humanistic and positive attitudes have supported inmate treatment and rehabilitation programs in a prison than custodian attitudes that favoured strict adherence to rules and a primary focus on security and control. Further it was revealed that those staff who were negative in their attitudes have less faith in correctional programmes and there was little value to be achieved through reformations oriented activities. They also felt that such correctional programmes are nuisances and are privileges of which inmates are not worthy. Obviously such attitudes will influence inmate thinking about actively participating in treatment and

rehabilitative programmes and limit the success of prison reformation programmes.

As mentioned earlier, the attitudes of prison staff especially that of the guarding staff, are crucial because they are the group that has the most contact with prisoners. Taking this fact into account, APCA has undertaken a primary research to study the attitude of prison staff towards prisoners by collecting data from the guarding force working at Central Prison, Vellore. A standardized psychometric tool, i.e., Attitude towards Prisoners scale, developed by Kenneth B. Melvin, Lorraine K. Gramling and William M. Gardner in 1985 was utilized. The ATP scale is a 36-item Likert-type scale assessing the general attitude toward prisoners. It has good test-retest reliability and excellent internal consistency. The study has covered 50 prison staff from warder to chief head warder cadre.

Primary analysis of the above study results indicated that the prison guarding forces' attitudes were relatively negative. The overall scores were not much higher, which means the attitudes held by them are rather negative (i.e., Mean ATP -88.28 in a scale of 0-144; SD - 20.14; range - 56-129). This result is consistent with some previous researches on this topic, as earlier researches have proved that groups with lowest average ATP scores consisted of law enforcement officers. This finding needs discussions and further investigations. The key factors responsible for formation of negative attitudes among prison warders needs to be identified and necessary remedial measures needs to introduced, because positive attitude of prison staff toward prisoners is one of the crucial variables leading to positive changes in prisons and successful reformation and rehabilitation of prison inmates.

Therefore it is quite evident that the guarding personnel in prisons shall have a great deal of positive attitude to enable effective reformation of prison inmates. Active participation and positive attitude of prison staff is very important in implementation of reformation programmes.

Specialized trainings have to be introduced to achieve this goal. In addition to the basic training of nine months duration, special training programmes for a duration of two to four weeks on related subjects and counselling skills needs to be imparted to the guarding force with an explicit view of reorienting their attitude. Further, it is equally important that the guarding staff are provided with necessary rewards including reasonable pay and other incentives to maintain a decent standard of life. Without giving them adequate pay and rewards, we cannot expect them to be motivated and committed in their work.
